# Over 1,400 Victims in Kota Setar, Kedah, Received Timely Flood Relief Aid from LTAT and Its Group of Companies

**KUALA LUMPUR, 26 SEPTEMBER 2024** – In the wake of the recent devastating floods in Kedah, Lembaga Tabung Angkatan Tentera ("LTAT"), in collaboration with its Group of Companies — Boustead Plantation Berhad ("BPlant"), Boustead Petroleum Marketing Sdn Bhd ("BHPetrol") and Pharmaniaga Berhad, has recently mobilised essential relief aid swiftly to over 1,400 affected victims across eight (8) Temporary Flood Relief Centres ("PPS") in Kota Setar, Kedah, on Tuesday.

This collective response underscores LTAT, and its group of companies' commitment to standing shoulder-to-shoulder with those impacted by the floods, providing critical support during a time of need alongside other GLIC and GLC counterparts in driving a collective impact as part of the GLIC/GLC Demi Rakyat & Negara ("GDRN") coalition. Over 800 essential packs were distributed, including food and toiletries, tailored to meet the immediate needs of displaced families.

## Distribution Details by LTAT's Group of Companies:

- Boustead Plantation Berhad: 500 essential food packs delivered to 6 PPS locations.
- **Boustead Petroleum Marketing Sdn Bhd:** 180 essential food packs distributed across 3 PPS locations.
- Pharmaniaga Berhad: 165 essential toiletry packs delivered to 3 PPS locations.

These efforts were part of a coordinated relief mission between the Disaster Operations Control Centre ("PKOB") and the PPS in Kota Setar, ensuring aid reached families efficiently and safely. All recipients are currently housed in designated PPS locations, overseen by local authorities and professionals, ensuring their immediate well-being and safety.

This successful aid distribution not only addressed the immediate needs of flood victims but also demonstrated the strength of group-wide collaboration. The LTAT Group's rapid response provided much-needed relief, easing the burden on families as they await the floodwaters to recede and normalcy to return.

LTAT remains committed to providing ongoing support and actively contributing to society, fully aligned with the economic aspirations of the MADANI framework.

#### About the Lembaga Tabung Angkatan Tentera ("LTAT")

Established in August 1972 under the Armed Forces Fund Act (also known as Act 101), the Lembaga Tabung Angkatan Tentera ("LTAT") is a statutory body which manages the pension fund for officers and members of other ranks of the Malaysian Armed Forces ("MAF") and the veterans.

The latest amendment to the Act was made on 1 November 2022. As of 31 December 2023, LTAT had assets under management of close to RM11.54 billion. LTAT declared a 5% dividend for members in 2022 after paying 4.1% in 2021, 3.5% in 2020, 2.5% in 2019, and 2% in 2018.
